1.3 Minutes and Actions

1. The previous minutes of the Wellbeing Advisory Group from 16 October 2020 were confirmed.

2. Operational Update

2.1 GCCRS Operational Update

- **1**. The GCCRS October 2020 Directors Report, as attached to the agenda, was taken as read and discussed.
- **2.** Demand for the GCCRS service remains strong but is beginning to slow as the end of the year approaches. The GCCRS Satisfaction survey data is being closely monitored in response to the strong demand.
